Allcargo Supply Chain Private Limited (Entry No. 38) and Gati Express and Supply Chain Private Limited (Entry No. 39) were merged with AGL (Entry No. 37). 2. Subsequently, AGL was merged with ALL (Entry No. 29). 3. Transindia Real Estate Limited's Promoter and Promoter Group, holds more than 20% of the shareholding in Allcargo Global Limited, in accordance with the definition of Promoter Group under Regulation 2(1)(pp) of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018.
